Team Rounds: Time and number of arrows has been reduced. Four - 2 minute ends for three archers

to shoot 2 arrows each for a total of 24 arrows.

Elimination Rounds: All rounds are now 12 arrows. Tentative: at the Arizona Cup, 1/32nd round thru

1/8th round will be 2 ends of 6 arrows, quarterfinals and semi-finals will be 4 ends of 3 arrows.

Medal Rounds: Alternating shooting allows 30 seconds per arrow.

Team Rounds: There are two separate team rounds. An Official round and an Open round.

Arizona Cup International Team Round (Offical): Pre-registration of an official team must be

received by March 24. See rules on page 4.

Arizona Cup Open Team Round registration fee of \$15/team will be collected at the field for the open team rounds. Deadline to register a team is 10:30am on Thursday, April 6th. See rules on page 5.

Awards will be given to the top three archers in the four official categories for the total of the Awards:

- 3. Nations may field one official team per country per category. Archers not in the official round may compete in the open round.
- 4. All Teams should wear matching shirts.
- 5. All archers must wear appropriate footwear. This means shoes or sandals appropriate for a desert setting.
- 6. New FITA rules for Team Rounds will be in effect.
- 7. Teams will be seeded based on the team's combined 72 arrow 70m scores first qualifier.
- 8. Only one registration form per team needs to be returned.
- 9. Deadline for Final Team Registration is 10:30am, Thursday, April 6th. Pre-Registration is due no later than March 24.
- 10. Team Registration forms may be received independently from individual's registration form.

- 12. In the event there are not two or more teams entered in a category, then that category will not be contested.
- 13. Any USA Collegiate archer that is also one of top three USAT qualifying archers may choose to be in the Official Round or in the Open round with their collegiate team.
- 14. A vacancy on the USA team may be filled by the next highest USAT archer as determined by the first 72 arrow 70m qualification round.
- 15. 2006 USAT members should bring their USAT shirts to the field.
