## 2007 JOAD/Adult Club Invitational

## Hosted by The Papago FITA Archers

The 2007 JOAD/Adult Invitational is a series of three tournaments for members of an Arizona JOAD or Adult Archery Club. Each tournament will be a 1/2 FITA (18 arrows at 4 distances). An Archer must be a member of an Arizona Archery Club (NAA, NFAA, ASAA, etc. doesn't count) to participate. The Archer must shoot in at least two out of the three tournaments to be eligible for awards. The Archers top two tournament scores will be used for determining a series champion in each division. An award for the top club will also be given based on club participation in all three events.

## **Liability Waiver**

(All participants must sign. Parents of minors must sign for youth.)

IN CONSIDERATION of being allowed to participate in a Papago FITA Archers event (whether hosted by the Papago FITA Archers or another group or individual at the Papago Sports Complex FITA range) including archery practices, instruction, and/or tournaments (collectively referred to as "Activities") I acknowledge and agree that:

- 1. I understand dangers may be caused by my own actions, or inaction's, as well as the actions or inaction's of others participating in the Activities. I understand the nature of the Activities and acknowledge my experience and capabilities and believe I am qualified to participate in such Activities. I further acknowledge that I am aware that the Activities will be conducted in facilities open to the public. I further agree and warrant that if, at any time, I believe conditions to be unsafe, I will immediately discontinue further participation in the Activities.
- 2. I FULLY UNDERSTAND that:
  - (a) the Activities involve risks and dangers of SERIOUS BODILY INJURY, INCLUDING
    - PERMANENT DISABILITY, PARALYSIS AND DEATH (Risks);
  - (b) these Risks in which the Activities take place or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW;
  - (c) there may be other risks and social and economic losses either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES incurred as a result of my participation in the Activities.
