LOCATION: Ben Avery Shooting Facility, FITA Range, Phoenix, Arizona

MEMBERSHIP: USAA/NAA and Arizona residency required to make the Duel Team.

GUESTS WELCOME: Non-NAA or non-AZ resident archers are all welcome to take part in the Guest category.

FORMAT: FITA – 36 arrows at 4 distances = 144 arrows ALL MASTERS WILL SHOOT THE SAME DISTANCES AS THE CADETS AS FOLLOWS - Masters Men & Cadet Men will shoot from 70, 60, 50, 30 meters; Masters Women & Cadet Women will shoot from 60, 50, 40, 30 meters. If individuals wish to shoot the longer distances to qualify for the Arizona Duel Team, they must register as a senior archer. The Cub Division will shoot 50, 40, 30, 20 meters. The Bowman division will shoot 30, 25, 25, 20 meters.

AWARDS: The Duel Team will have their Duel registration paid and receive a team shirt. JOAD archers will receive awards for places 1st, 2nd & 3rd. No other awards will be given.

RULES: USAA and FITA rules. The New NAA dress code will be enforced. <u>http://usarchery.org/resources/rules-regulations/usaa-dress-code</u> At 30 meter (short) distance, all Senior, Junior, Cadet, and Master categories must shoot on a 6 ring multi-face setup, unless <u>ALL</u> archers on that target agree to use a single 10 ring.

DUEL TEAM SELECTION: Must be able to Compete in the Duel in The Desert Arizona on November 6 & 7, 2010 to be held at the ben Avery Shooting Facility. AZ Duel in the Desert team membership is open to all current USA Archery members that are listed as an Arizona resident in the Senior and Junior categories. Note that the ASAA reserves the right to appoint Arizona Duel team members should there be insufficient number of ASAA member archers in the trials competition. Appointment may include inclusion of Arizona Masters, JOADs and review of other event results. There will be a 2010 Az Duel Team Members meeting on the Field after the trials.
