

# 2011 Arizona State JOAD Indoor Championship

### Saturday, February 5, 2011 Phoenix, Arizona



<u>VENUE:</u> Ben Avery Shooting Facility Indoor Archery Range 4044 West Black Canyon Boulevard, Phoenix, AZ 85086

FORMAT: Single FITA I – 600 Round Indoor Tournament (60 arrows) (STAR FITA registered)

The Tournament determines the Arizona State JOAD Indoor Champions for the following Classes:

#### **Bowman and Cub Classes, AM session**

**Recurve Bow and FITA Barebow** - 60 arrows from 18 meters; - 60 cm target face single 10 ring target, outer 10 ring scoring.

**Compound Bow-** 60 arrows from 18 meters; - 40 cm target face (choice of single spot, triangle or vertical three-spot face; outer 10 ring scoring.

<u>Juniors and Cadets Classes, AM Session</u> (Juniors and Cadets may move to PM, see Special Notice) **Recurve Bow and FITA Barebow** - 60 arrows from 18 meters; - 40 cm target face (choice of single-spot, triangle or vertical three-spot face); outer 10 ring scoring.

**Compound Bow-** 60 arrows from 18 meters; - 40 cm target face (choice of single spot, triangle or vertical three-spot face; use inner 10 ring scoring.

#### Open Barebow Novice, PM session

**Open Barebow Novice** (Example: Archery in the Schools Type Bow) - 60 arrows from 18 meters; - 60 cm target face single 10 ring target, outer 10 ring scoring.

#### **REQUIREMENTS AND RULES:**

**USA Membership** - USA Archery membership is required to compete for the JOAD State Championship. If your USA Archery membership expires prior to the official start date of the tournament, a copy of your USA Archery membership renewal and payment must accompany your tournament registration form. Your application will not be considered complete until your current membership is on file with USA Archery. Please be prepared to show USA Archery membership card at the tournament registration table or be prepared to purchase a USA Archery membership at that time. <a href="http://usarchery.org/membership">http://usarchery.org/membership</a>
