Although pre-registered, all AZ/CA team members must have a signed waiver on file with the tournament prior to official practice. Minors must have a waiver signed by parent or official quardian. Waivers may be submitted with team payment.

**TOURNAMENT MEDALS:** Medals will be presented for the Open competition.

TARGET ROUND: 144 arrow FITA round: for Duel in the Desert and the Open competition.

To comply with the Duel Rules: All long distance ends are 4 minute 6 arrow ends and all short distance ends are 2 minute 3 arrow ends Target face definition: 122=122cm ten ringed target face, 80-10=80cm ten ringed target face, 80-6= 80cm six ringed target face.

#### Recurve, Bare bow and Compound
