



## Hearn Archery's Copper Classic Information and Registration

### 300 Round Scoring then a Match play shootout of top 16 archers each day.

**Format:** Open 300 Round - Vegas Scoring - Outer 10 in the morning. Lunch break, then in the afternoon, the top 16 shoot it out head to head in two flights.

**When:** JOAD on December 1<sup>st</sup>, 2012- Adults on December 2<sup>nd</sup>

**Where:** AZ Archery Club 1115 W. Deer Valley Rd. Phoenix AZ

**Cost:** Saturday December 1<sup>st</sup>-Youth = \$30 (\$25+\$5 lane fee) - Archers under20;  
Sunday December 2<sup>nd</sup>-Adults \$40 (\$30+\$10)

**Registration is limited to 52 archers per day.**

#### **Ranking Round Details:**

Distance: 18 meters, indoors.

Scoring: Vegas style scoring (Outer 10).

Tiebreakers will be determined by X count, then 10's, then 9's.

Targets: 40cm single face, Vegas 3 spot or Vertical 3 spot.

Categories and Divisions: Bowman: up to 12 years of age, Cub: 13-14, Cadet: 15-17, Junior: 18-20, Senior: 21-49 Masters 50+. Divisions will be split between compound, recurve, male and female. Genesis bows will be considered a compound bow and may have sights.

#### **Schedule:**

Morning Session - two lines (AB-CD)

8:30 AM Check-in, Set-up and equipment inspection (Open practice may be available)

9:30 AM  $\frac{1}{2}$  hour official practice

10:00 AM Scoring begins (30 arrows)

11:30 AM Awards for the Ranking Round

Afternoon Session - The top 16 archers will be ranked by overall score, regardless of equipment type, classification, or division. Archers ranked 1-8 will be in the Copper Flight, archers ranked 9-16 will be in the Turquoise flight. Archers will shoot in a round robin against 7 other archers in their flight. FITA Set System rules will be used.

1:00 PM Check-in (Open practice may be available)

1:30 PM Scoring begins

A plaque for the Copper and Turquoise Flight Awards will be given after all round robins are complete each day. Winners list and scores will be posted on the AZJOAD and ASAA web sites upon completion of both sessions.

### **Rules and FAQ:**

How is the Round Robin seeded and how is it going to run?

- For the Round Robin, there will be two flights of 8 archers each based on the qualifying rank points. Your total score in the 300 round will determine your position in the round robin.
- 2 flights x 8 archers = up to 16 archers total (all matches will run simultaneously)
- Match points will be based on the FITA "Set Points" system, best of 5 Sets. Each set is 3 arrows. Based on end score, the winner gets 2 points, if tied each gets 1 point for that set.
- First to 6 or more set points wins that match. If still tied after 5 sets, then one arrow, closest to center, determines the winner of that match.
- All archers regardless of age, gender or bow type will be seeded based on their best qualifying score.
- The top scorers will be in one flight, the middle scorers in the second flight. This approach should keep the match play competitive since similar shooters will be matched.
- Round Robin match play will be shot on the Vegas 3 spot face, and both archers will shoot targets on the same height level so there is no top or bottom advantage.
- Any shoot-offs will be into the number 2 (top triangle) target spot.
- Winner of each flight will be determined by the most match wins. If tied, there will be a one arrow shoot-off.

**\*\*\*\*\*Cheering is not only allowed during the round robin, but encouraged.\*\*\*\*\***

**Other administrivia:**

- Arrows: Any arrow diameter up to 27/64" will be allowed, and any arrow point up to 27/64" will be allowed (NFAA Vegas Rules, maximum arrow diameter)
- Compound bow: Must conform to FITA rules for compound bow draw weight; maximum of 60 pounds,
- Sights: Multi-Pin sights are allowed (NFAA Vegas Rules, Bowhunter Freestyle class)
- Electronics: Archers are not allowed to have electronics on their bow or on the shooting line
- Music: Music will be played in the background.
- Awards: If there are less than three archers in a category (i.e. Cadet Female Recurve), only a first place award will be given.
- If there are three or more archers in a category, awards will be given to the top three in that category for the ranking round. Only one award will be given for the winners of each flight.
- All archers or their guardians must sign the ASAA and USA Archery waiver
- Lane sizes are set by availability in facility.
