**Update Oct. 13**: The National judge test will be administered after the 29/30 USA Archery Arizona judge seminar to eligible national judge applicants. To apply and determine eligibility, email your request to Sheri Rhodes <a href="mailto:srhodes@usarchery.org">srhodes@usarchery.org</a>. Include the following information:

- 1. Request to become a USA Archery national judge.
- 2. Full Name as listed in the USA Archery membership database:

- 5. List the most recent USA Archery national level outdoor tourney you judged.
- 6. List the most recent USA Archery national level indoor or field tourney you judged.
- 7. List the most recent applicable workshop/seminar/webinar you attended or indicate you plan to attend the 29/30 October 2016 USA Archery Arizona Judge Seminar, Phoenix.

Upon receipt, pre requisites will be verified and notice sent via return email. Please verify you have met the criteria before applying including:

- USA Archery membership in good standing.
- Safe sport training certification.
- Minimum three years as a USA Archery judge.
- Complete judge duty at a USA Archery national level outdoor tournament.
- Complete judge duty at a USA Archery national level indoor or national field tournament.
- National event COJ performance report.

Participation in a "USA Archery Officials and Rules Committee update workshop/seminar/webinar or World Archery Americas or World Archery Judge Seminar/Workshop/Conference". Note that the 29/30 October USA Archery Arizona Judge seminar qualifies for this requirement.

**Who:** Persons interested in the rules and judging archery tournaments.

- Basic and Advanced Judge knowledge and training seminar.
- USA Archery members one year or longer, 18 years of age or older may sign up to become a USA Archery Judge. (USA Archery fee is in addition to seminar fee)
- Coaches, archers, event managers and future judges are invited to participate to refresh and update rules and procedures knowledge.

**What:** Basic and advance rules procedures and updates. Topics include:

- Philosophy and goals Judge, tournament organizer, and staff opportunities Preparation and inspection - Ranking round process - Individual matches and team round process -After competition.
- Exercises and case studies.
- Those that meet USA Archery Judge Program certification requirements may bring their wifi
  enabled computer and take the USA Archery certified judge exam at the end of the
  seminar. Certification fees are in addition to this seminar fee.

When: 2 day seminar

- Saturday, October 29, 8 AM to 5 PM and Sunday, October 30, 8 AM to 4 PM.
- National judge testing and review may extend to into the evening on Sunday.
